Presidential Search

I assume that you have all seen the email pertaining to how the Board of Regents will be moving forward in regards to finding a new president for the college. The executive committee have discussed it and will be drafting and sending a letter to the board that will call for greater faculty input into the selection process. I feel that it is paramount that the faculty is on record requesting a role in this process.

Faculty Senate

In a somewhat related area, I would like to remind you all to provide any input you have about us moving forward in trying to create a faculty senate to your division representative. I would also like to remind you that if we do successfully create a faculty senate that each and everyone us will have a lot more work to do. In asking the regents and the administration for a larger say in the policy and governance of this institution, we will be taking on the task of ensuring that representation and transparency are met. What I mean by this is that as a faculty we will have to be diligent in our reporting about committee meetings and ensuring that we show up to meetings and campus events. We are asking for a greater role in the process, and therefore we must also recognize that we must foster all democratic actions.

Adjunct Participation

We will have language to amend our constitution to allow for adjunct participation prior to our January meeting. In regards to some concerns about administrators who work as adjuncts being able to participate, we also have some language that ensures they will be excluded. I will send the language out to you all before we leave for winter break, so that we can vote on the amendments at the January meeting.

I encourage you all to work your spring schedules so that you are able to attend this chance to advocate for the college and our students. We are, as always, facing a tough legislative session, and every contact helps to change people's minds.
