#### EXPLANATION OF COSTS:

**Oklahoma Resident Tuition and Fees:** This approximate tuition is for students who need to take all courses required for graduation with the Associate in Applied Science Degree. If a student has previously taken general education coursework, that transfer, this amount is incorrect. Current cost for residents is \$135.29/credit hour. **Non-Resident Tuition and Fees:** \$326.99/credit hour.

**Application Fee:** \$20 selective admission application fee for PTA applicants

**Enrollment Fee:** This is a one time fee for each student who is taking the first class at OCCC. If a student has been attending classes at OCCC, this fee has already been assessed/paid

**OCCC ID cards** are required to use the facilities including the test center and Keith Leftwich Memorial Library. The cost is a one time fee of \$10.00. If card is lost, \$10.00 fee will be required to make another ID card.

**Book costs** are approximate and will vary depending on location of purchase. Books will be an excellent resource throughout the career of the licensed PTA.

**PTA student liability insurance:** The est.student liability insurance fee must be paid annually each fall at the Bursar's office. The insurance will cover the student in lab and while on clinical rotation. The student will not participate without the insurance.

**PTA Supplies:** These supplies are provided in a kit and include lab supplies such as goniometers, reflex hammers and gait belts-presented to students at the beginning of the lab courses. The comprehensive exam fee is included in the spring semester of the final year in program. The PTA supplies fees are paid with tuition and feel. Additional supplies/uniforms may be required for PTA students such as scrubs for clinical settings. The clinical facilities will notify the students if these items are required. These costs would be paid individually if needed.

**APTA-OPTA Dues:** Joining the APTA is voluntary but strongly encouraged. The students will gain valuable resources such as publications, full-text articles online, employment searches, networking opportunities and professional resources. Some textbooks available free online to members (savings of \$99.00). APTA membership is \$80 and OK membership is \$20 for a total of \$100.
