

**EDUCATIONAL SERVICES AGREEMENT BETWEEN
OKLAHOMA CITY COMMUNITY COLLEGE
And
OKLAHOMA CITY PUBLIC SCHOOLS**

Oklahoma City Community College (OCCC) and Oklahoma City Public Schools (OKCPS) agree to the provisions specified below:

During the 2009-2010 academic year, contingent upon availability of qualified OCCC instructors, OCCC will offer college-level courses to qualified concurrently enrolled high school students within the OKCPS high school system as follows:

COURSES TAUGHT AT HIGH SCHOOL SITE

Oklahoma City Public Schools will provide appropriately equipped classrooms for all courses offered.

OCCC will provide enrollment assistance and a qualified instructor for each course.

Each course offered will be at a cost of \$1,025.00 per credit hour for a maximum of 10 students. An additional \$102.50 per credit hour will be billed for each student over the maximum of 10.

Lab Science classes will be billed as above with an additional \$15.00 per student lab fee.

Oklahoma City Community College will waive up to six (6) credit hours of tuition per semester @ \$60.55 per credit hour for each senior enrolled. The exact amount of tuition waived will be determined at the completion of each semester and subtracted from the total course costs prior to invoicing.

REGULARLY SCHEDULED CLASSES

Eligible high school students who enroll in regularly scheduled, on-campus college classes will be charged the standard rate of \$84.00 per credit hour (\$60.55 tuition and \$23.45 in fees).

Students who enroll in a lab science class will be charged an additional \$15.00 per credit hour.

Students who enroll in online classes will be charged an additional \$12.00 per credit hour.

Oklahoma City Community College will waive up to six (6) credit hours of tuition per semester @ \$60.55 per credit hour for each senior enrolled. The exact amount of tuition waived will be determined at the completion of each semester and subtracted from the total course costs prior to invoicing.

REQUIRED BOOK COSTS

The cost of books will be determined in accordance with the class offered. Costs may be estimated at between \$75 and \$100 per class.

RESIDUAL ACT EXAMS

OCCC will provide Residual ACT testing for students at \$35.00 per exam.

OCCC will prepare billing invoices for the Fall and Spring semesters as soon as the enrollment count has been determined. Oklahoma City Public Schools will provide payment to OCCC for the educational services provided for these students within 30 days of receipt of invoice.

The total cost for this agreement shall not exceed \$230,000.00
