- We are investigating Med Lab Tech program (MLT). There is a gap of 14% of available MLT's employment techs in Oklahoma. In the future, technicians will not be able to get a job unless they have a certificate. Deaconess came to us and asked us to put in a Lab Tech program.
- Polysomnography tech (sleep lab) is another program we are looking into offering at FT.
