2. Conferences attended/no presentation, please forward to Susan Vanschuyver

Jo Ann asked the members to send the names and dates of the conferences they have attended, specifically those where no presentations were given, to Susan Vanschuyver. She will be collecting them for the upcoming HLC site visit.

3. Graduation

Jo Ann reminded the members that Graduation is on May 8th. She reminded the members that attending graduation is a contractual requirement. If you are not able to attend, faculty are to email their Program Director and Dean. The email will be forwarded to Dr. Aquino for approval. Faculty are to take either personal leave or vacation to cover the time missed.

4. Budget for 2010

Jo Ann informed the members that there will be a budget shortfall this year. The college is expecting a 5% cut in the budget. Seventy-five percent of the cuts will come in Budget and Finance and ITS. The only initiatives that have been approved for Health Professions will be those that are in student technology. There will be no raises. If the college receives stimulus money it will go in to the contingency fund, to be used accordingly. There also will not be a raise in tuition this year.

5. Institutional Committee assignments for 2010

Jo Ann referred the members to the handout (attached) listing the committee assignments or the next academic year. She asked that the members, once the fall semester begins, let her know of any conflicts. Also if anyone is especially interested in being on a committee, please let her know.

6. Walk up copy machine

Jo Ann shared that the costs per copy for the new machine is expected to be about a penny per copy. She asked the members to email her if they intend to use the new machine and an approximate number of copies they expect to make.

7. Two pilots Fall 2009

a.) SII's

Jo Ann referred the members to the handout (attached). The handout lists the questions that will be used on SII's beginning in the Fall. The scale used will be the Likert scale. There was some question concerning 5 point or 4 point. Jo Ann stated that the exact scale to be used will be determined by Institutional Effectiveness.

b.) Faculty Advising

Jo Ann informed the members that they are starting a faculty advising program. There will be times that the faculty can volunteer to advise and assist students. They will be located in the Advising area during determined times of the year and available to assist students interested in all of the Health Professions. 9. Program Updates/Committee Reports

- Jennifer Ball reported on behalf of the Faculty Association Scholarship Committee. They are looking for new fundraising ideas. They currently have the Garage Sale and Make It – Bake It. They are considering dropping the garage sale due to lack of volunteers. They are considering a Daddy/Daughter Dance to be held in February. They are also considering a 5K run.
- Jen Halpin reported on behalf of the adhoc clicker technology committee. They are moving towards having clicker technology available campus wide. They are currently reviewing clicker providers. Whoever is chosen will have to interface with Angel. They are planning a trial run in the fall semester. She asked the faculty members to provide input.
- Rosemary Klepper informed the members that the Oklahoma Board of Nursing survey visit will occur on October 26th and October 27th with the bulk of the meetings being on October 27th.
- Vicky Davidson reported on behalf of the Faculty Association. She reminded the members of the resolutions contained in the college wide email.
- Rosemary Klepper shared that she had confirmed that the Nursing Program had 473 students in AY2008-2009. She also shared that the Nursing Pinning Ceremonies will be held on May 15th at The Rock and May 16th at Southern Hills Baptist Church.
