Division Meeting Social Sciences Division May 2, 2006 1H7 - HTC Building

Cecelia Yoder opened the meeting by inviting everyone to share the cake she made to celebrate the near end of another successful semester. The cake was from a recipe of the late Dr. Peter Wright of the History Department.

The Gen Ed and Scholarship committee reports were distributed. Jane Carney gave the report from the Benefit's Committee. She reported:

- personal leave for faculty now is 5 days before banking
- retiree spouses may use Wellness Center
- extended leave will begin in Fall 2007

Other items are still before the committee but not yet approved. She asked that the faculty be aware that insurance premiums will be rising as will co-pays. The committee is reviewing HR Policies and Procedures and changes will be made in the Family Leave Act. Everyone will need to update beneficiary information for life insurance by June 10. It was mentioned that life insurance benefits are reduced as the employee ages.

Dana Glencross presented a written proposal for loaning textbooks to students on an emergency 30 day basis. Arts & Humanities uses this program and have asked us to join them. It would be for first time, first semester students only in the basic courses. Books would come from Publisher donations and housed probably in the division office with someone, (perhaps Mary Barr) in charge of distribution. Dana Tuley Williams said it was not an option to house them in the library.

Discussion was held as to having the student be responsible for returning the books and that holds could be placed on transcripts until they are returned instead of the attitude they might not be returned and that would be accepted. It is ideal that they be loaned for only 30 days rather than all semester. Probably the information as to availability of books for loan could come from Counselors instead of widespread announcements. Dana asked that any thoughts on this proposal should be emailed to her as soon as possible.
