Student Opinion Survey

INTRODUCTION

The ACT Student Opinion Survey has been administered at Oklahoma City Community College every other year since 1996. The results of this survey are analyzed to determine the areas which need to be addressed. This analysis is used to develop plans to improve various services across the campus.

METHODOLOGY

Faculty administered the survey in class to a stratified random sample of classes based on meeting time and type of class (remedial, technical/occupational, university parallel). This technique provides a sample of students which reflects the College's on-campus credit student population. The Survey was administered during the last week of February 2008.

RESULTS

There were 1016 survey forms completed in the Spring of 2008. This response represented 8% of the total credit student population for the semester. This response rate was similar to the Spring of 2006 in which there were 1002 usable survey forms.

Demographics

The demographic information included the following:

- 44% under the age of 21
- 59% white, 9% Hispanic, 8% black, 8% Asian, and 6% Native American
- 53% females
- 73% unmarried
- 75% working (23% working 31 to 40 hrs a week and 16% working over 40 hrs a week)
- 64% enrolled full-time
- 66% taking day classes
- 49% intend to transfer and 33% intend to obtain an associate degree
- 30% entered directly from High School and 28% entered after working a period of time
- 71% OCCC was first choice
- 77% would choose OCCC again
- Top five reasons for attending
 - 1. Low cost
 - 2. Offered the courses I wanted
 - 3. Could work while attending
 - 4. Good chance of personal success
 - 5. Convenient location

The overall impression of the quality of Education at OCCC included 88% of the students who selected good or excellent.

OCCC Compared to the National Norm

The survey was divided into seven categories including college services, academic, admissions, rules and regulations, admissions, facilities, and general. This information is included in

Appendix A. OCCC also asked 30 additional questions. These detailed results are in Appendix B. Appendix C includes student comments with people's names redacted.

Historically, the College has identified the items in which the results were statistically significant between the College average and the national norm. This year's results are presented in Table I. There were 21 items on the list in 2008 that were statistically higher than the national norm including academic calendar, athletic facilities, attitude of teaching staff, availability of courses, cafeteria/food services, class size, classroom facilities, college media, computer services, condition of buildings and grounds, flexibility in designing program, laboratories, library/learning resources center, OCCC in general, opportunities for involvement in College activities, parking facilities and services, racial harmony, rules governing student conduct, student union, study areas, and variety of courses offered. Of these 21 items, there were seven on the list in 2008 but not 2006. These seven included the academic calendar, attitude of teach staff, availability of courses, classroom facilities, racial harmony, rules governing student conduct, and variety of courses offered.

There were four items in which the College decreases declined statistically significantly when compared to the national norm. These items are identified in Table II and include financial aid information provided before enrolling, industrial arts/shop facilities, quality of instruction in the

student's major, and student employment services. Two new ones on the list were industrial arts/shop facilities and quality of instruction in the student's major.

There were also several items which were on the charts in 2006 but not in 2008. There were seven items which increased statistically from 2004 to 2006 but not from 2006 to 2008. These items included business/training facilities, college bookstore, testing/grading system, value of the information provided by your advisor, accuracy of college information you received prior to enrolling, opportunities for student employment, and general admissions and entry procedures There was one item which reflected a negative statistical significance for the previous five times that the survey was administered but not from 2006 to 2008. This item was financial aid services.

OCCC 2006 Compared to 2008

The College also received statistical significance tests on changes which occurred within the College from 2006 to 2008. There were two items which increased significantly including financial aid services and classrooms. The statistical difference between the ratings of classroom facilities in 2006 compared to 2008 was significant to the .001 level.

There were five items that decreased significantly including cafeteria/food services, College Bookstore, parking facilities and services, library/learning recourses center, and the testing/grading system.

I haven't attended this college long enough to judge it by a whole, but the two experiences that I have had have been negative and are as follows: A teacher, . . ., went ballistic the week of finals, she didn't let anyone finish their presentation, and told some groups (in front of class), she didn't think we'd pass the presentation. And also the lab assistants in the science lab aren't my mother or father and don't need to act like it. They told me I could call to schedule labs, and when I did they told me I couldn't and I told them that it was due the next day and they said well you should not have waited until the day before it was due. Their jobs are to help and instruct.
- 31. Some classes should require below 80% in a test, but pharmacology did not which makes me fail it. After I did all that was expected of me.
- 32. In the Arts program specifically this school excels with their staff in terms of knowledge, instructing, and overall quality. . . . and . . . are leading an exceptional program.
- 33. A suggestion is to offer even more online and night classes. Greatly improved since 2000 though.
- 34. I am very impressed with my online courses. The biggest positive at OCCC is the faculty. My teachers have been extremely knowledgeable, patient, respectful, and professional.
- 35. I wish there were more of my major classes offered at more flexible times.
- 36. Look to expand the Science courses offered (e.g. Geology). Engineering program, offers numerous courses. Only 1-2 geology courses offered. Geology is a growing field and a high-demand degree should offer more courses in the field.

37. I have had more than one professor who is consistently late for class; and another who assumes the entire class doesn't care about writing in Comp. II.

Advising

- Academic Advisement needs improvement in the area of communication to students what is necessary and what courses transfer to 4 year colleges. This should be done with all new students.
- I personally think that every student should be told who their faculty advisor is especially for those enrolled in the medical assisting program here. That would be extremely helpful.
- 3. I wish I had more help picking my major.
- 4. I have not spoken to an advisor here this time, but I have met with one at UCO last fall one time.
- 5. Advisors do a good job of putting together schedules that run together so that you have little "dead" time between classes and you can go on with your day when you are done. Also, OCCC offers good advising towards transferring to a 4 year college such as OU.
- 6. When I met my faculty advisor for the first time, he basically told me that because of my lack of interest for science, I would not be a good candidate for my preferred career, despite the fact that I already have job experience in that field. I think, as a faculty advisor, one should encourage and help reach the goals of the person he/she is helping.
- 7. I think every student whether they have declared a major or not, should have an assigned advisor. The advisor should be responsible for staying in contact with his/her students throughout the semester.
- 8. The advisors didn't help me at all. They kept sending me to different people.
- 9. The advising center responded to my request for an appointment after almost a month and I had to figure things out on my own.
- 10. The advisors should be more educated and qualified to give career guidance.
- 11. My advisor has not given me much help- I've learned more from other students.
- 12. I would strongly recommend adding more staff in registration/advising desk, because there is usually only one person there with a long line.
- 13. People need more info regarding the availability and role of their advisor. I was not aware of them until recently. The mailer sent out when I was assigned an advisor was vague and uninformative.
- 14. I have used the advising services twice, and was not given any advice as to what courses I could take to achieve the degree I wanted. The advisor I spoke to simply was not knowledgeable. I would only suggest improvements in the area of the student advisors and making various services that available known to students.

Bookstore

- 1. Cheaper books & better resale in bookstore
- 2. Sell books at COST!
- 3. The bookstore is overpriced.
- 4. Bookstore needs to be improved in terms of services and options of goods.

- 5. The college needs to improve the service and quality of the bookstore. About book store, much kinder attitude to the customers is needed, and more detailed, easy directions such as return policy need to be posted for the international student.
- 6. It's the prices of books when you return them you don't get that much money.
- The bookstore should be open later. I and others work during the day and b the time we make it to the college, needing to get supplies or materials at the bookstore, it is already closed.
- 8. Reuse textbooks for more than one semester.

Cafeteria

- 1. Cafeteria needs to be improved in terms of services and options of goods.
- 2. The college needs to improve the service and quality of the cafeteria. At cafeteria, more choice and better quality with reasonable prices are needed because the customers are mostly students who usually don't have jobs.
- 3. The food selection only includes fried or junk food (besides the salad bar) and needs healthier choices. Milk in the vending machines is almost \$2 for a half pint. Way to expensive.
- 4. Though I like the smaller school environment, it does need to expand in the field of food. Lunch time comes around and you can be standing in line for 20-30 minutes waiting. I suggest having a building designed just for food services. Then students will have more options and there won't be as big of lines.
- 5. More healthy food options should be offered in the union and lower prices.
- 6. The cafeteria should be open for evening classes, especially since so many come straight form work.
- 7. I have eaten at the cafeteria on two occasions and have two suggestions; Provide a quiet area for those wishing to study while dining rather than socializing, and reevaluate cafeteria prices—they seem excessively high to me and with so many fast food/restaurants in the immediate area, I would opt to go out as opposed to eating here.
- 8. The cafeteria is way too expensive.
- 9. Prices at the cafeteria are unreasonable.
- 10. The cafeteria is overpriced.

Enrollment

- 1. I think this college is wonderful except for the enrollment/advising area. First they lost my application and I had to fill it out again. Also, I felt very rushed. The women in the advisement area did not know what classes were prerequisites to my classes. They did not know the classes that transferred from OU to here. I think this area of your college needs the most improvements. (This is the first place people come and should leave a good impression.)
- 2. The ladies who registered you for classes are very unfriendly and seem not to care.
- 3. All kinds of problems with enrollment, counselor never enrolled me, financial aid basically was kind of rude when I first tried to get information. They would seem to just want me to go home or get out of the line fast. I had a lot of questions and basically denied me. I would have liked to know this before \$2,500 Bursar Bill. Financial aid needs to answer more specific questions when people ask.

- 4. Not very satisfied with registration/enrollment. The person who helped me was very rude, not helpful, seemed impatient because wanting to go home. I work until 5 everyday so the hours I can come here are very limited and I am as well tired and would like courteous, professional and helpful staff.
- 5. The enrollment center is so helpful.
- 6. Enrollment should be a smooth uncomplicated process!

Financial Aid

- The financial aid department at OCCC is very discouraging the staff is very belittling of students. The financial aid staff at OCCC to my experience has acted as if a hand out is what I am asking for instead of financial assistance to attend OCCC that will be repaying later.
- 2. Speed up the financial aid process at our college. Make sure all forms needed are given to student for counselor review.
- 3. It has been very difficult to untangle the financial aid information. In the 2 years I have attended, I have never seen an accounting of how my financial aid is spent. I also have never had or spoken with an advisor.
- 4. My federal aid was denied even though I am unemployed because of my past income, am I supposed to wait for 1 ½ to 2 yrs to seek retraining via college? I am paying nonresident tuition because my residence wasn't Oklahoma in the military computer system. I joined military in Georgia when father stationed there. I have no family or residence there. Just think people that complete military service should have a choice in their residency after discharge and that they should be considered residents at that state.
- 5. The financial department took 3 months to process my paperwork. It took me going into their office for them to even look at my paperwork (3 months later) I had to pay out of my own pocket and get fees charged to my account all because the people in the financial aid office do not know what they are doing. I don't think I'll come here next semester because I don't want to deal with them and I still don't have an advisor 8 weeks later.
- 6. International students not allowed for federal financial aid.
- 7. I find it hard to believe that I can't get a scholarship or a grant. I keep trying maybe someday.
- 8. The financial aid seems to differ every semester even when my personal info hasn't changed for 10 yrs.
- 9. I do not agree with finance charges on payments.
- 10. Financial aid office is very disorganized. They do not fill paperwork the way it should be done. This financial aid office lost my transcript many times and they almost made me loose my grants form my tribe because they told be they sent it off and they did not. If I wouldn't have contacted my tribe when I did I would have lost it for the entire year.
- 11. The financial Aid offices are highly inconvenient; I have had problems with them repeatedly.
- 12. The financial aid department needs an over-haul. It took me calling NELNET and FASFA and visiting the dept. 2-3 times a week, for 7 weeks, to get them to do their jobs and process my student aid. I had no books for class during that period as well as it affected my grades. They blamed everyone at my old school, NELNET and FASFA- but my

- research found out they just weren't doing their job and made me feel as if they did not care for me at all.
- 13. Financial Aid should be a smooth uncomplicated process!
- 14. I have found support staff (financial aid, testing center, etc.) to sometimes be rude or unhelpful.
- 15. You should give some scholarships for foreign students or at least reduce their tuition.
- 16. International student not allowed for federal financial aid??? Some internship programs denied for international students.
- 17. A change needs to be made when it comes to billing members of the military. It can take some time for the military to approve and pay for the tuition and fees. The college still bills service member with no regard to this fact. The military will not reimburse a soldier for anything they pay, but they are still responsible for meeting payment deadlines on time. There needs to be something in place to take this burden off those service members.
- 18. I think scholarship information should be more open, public, and have easier access.

Library

- 1. The main things I have not been satisfied about are the Microsoft Word program NOT being in the library and communication labs.
- 2. I checked out a book from the library and felt harassed by my choice of reading.
- 3. College should open library a bit late on Saturday.

Recreation

- 1. The workout facility needs to be expanded and improved.
- 2. I would like for the OCCC to account the students more in the aquatic center. There are around 30 lanes to swim in total and only 3 are available for people who are actual students. This shows me that OCCC does not care about student satisfaction but only cares about the various high schools swim teams.
- 3. None really, if I had to say one thing. I'd say building a tennis court or a build a building for ping pong & pool players would be nice.
- 4. I personally would like a larger gym in which to exercise. That is all I can think of.
- 5. This college is in desperate need of informal sports. If by any chance it already does; then there should be some flyers put up or something.

Security/Parking

- 1. The security is not very good when walking out to my car at night; very dark, never seen any security and feel like I have to run to my car.
- 2. Make sure all parking lot lights are on at night when students are still leaving the school.
- 3. Parking is lousy. The person who designed it (especially around arts and humanities) wasn't practical. There's no need for the loop. It's hard for me to leave in a hurry!
- 4. Parking is becoming an issue.
- 5. Better parking instead of so much grass & bushes, have closer parking spaces. Even if you get a close parking space now, you still have so far to walk.
- 6. Being a theater major I find myself at school late at night for rehearsals and there have been times where I had to walk to my car in complete darkness. I suggest that the

- parking lights stay on at least until 0100. With this college being right off a highway, a woman walking to her car in complete darkness isn't very safe.
- 7. It would be nice if there was a sidewalk coming across the grassy knoll so the students aren't having to walk in the street or across the grass on the West/Northwest side of campus (when entering off 74th Street.) When the weather is bad it's not pleasant to walk through ice, wet grass, and mud, on the way to class. It would be beneficial to have a few more lights in the parking lot for evening class students to feel safer.
- 8. Parking at OCCC is terrible and the campus is not well lit enough at night for students to be safe walking to their cars.
- 9. Improvement in the number of security in the evening.
- 10. There should be a sidewalk down the middle of the median for students to walk down, verses walking on the roadway to/from the parking lot. It's dangerous.
- 11. There is no walkway from main entrance leading east to Western. I often walk in the road to and from my cat. Needless to say there are differing levels of driving ability on campus and I felt safety is an issue when walking toward east parking lot.

Student Services

- 1. There are too many departments and too many "students" working in these departments. If a student working in a department does not know the answer to my question they ship me off to another department where I can wait in line again just to be told I am in the wrong department. I am more than a student I am also a customer. The customer service is terrible all throughout this campus. Is this what to expect from a community college?
- 2. For events I think a little of everything would help other non students to attend.
- 3. At OU, most information is sent by email, enroll, financial aid, news, courses, activities we still not got at this point.
- 4. Quit sending letters to people with OHLAP telling them to come pay their tuition fees. It adds unnecessary student stress and clogs up the bursar's office with dumb questions.
- 5. You should give people from Africa their chance and not allow them to bring their High School transcript for them to enter college.

Testina

- 1. The testing area would be better if it was sound proof; I have trouble concentrating with lots of outside noise.
- 2. . . . who works in the testing center is rude, impatient, and walks into room making noise making it very hard to concentrate on my exams. People have complained about him before but nothing is ever done. Time for a change on yalls part. We work hard and study for hours before testing. Being treated with respect and courtesy would allow testing to be a little less stressful.
- 6. Testing Center people often rude.
- 7. The attitude of employees in the testing center is condescending and rude at times. I understand that their job is to policy cheating activities. However they need to remember that they are providing a service to a customer. I had an employee tell me that he could care less if I came into the center. He gets paid the same.
- 8. Test Center needs major improvements. Staff not friendly or helpful, and sometimes disturbance.

- 1. No student tuition fees.
- 2. Nice place to study!
