Purpose

This agreement is to facilitate the transfer of students between Oklahoma City Community College (OCCC) and Oklahoma Christian University (OC). Transfer students may be given full credit for their hours earned when the credit is appropriate to the student's degree program and the receiving institution has validated the courses.

Goals of the articulation agreement:

1. A seamless transition process that allows students from OCCC to transfer to OC and receive the maximum allowable credit towards a baccalaureate degree.
2. Clear transfer guidelines and degree plans that enable OCCC students to effectively plan their transition from OCCC to OC and gain the maximum allowable credit.
3. Effective means of communication to raise awareness among OCCC students of the opportunities available through this articulation agreement.

Agreement

1. OCCC students must meet OC's minimum academic and admissions transfer requirements in order to be considered for admission to OC.
2. All OC general education requirements must be fulfilled in a student's degree plan.
3. A maximum of 65 semester hours from community colleges may be applied toward degree requirements
4. The associate degree program must include at least 30 hours in courses typically required for the core curriculum with at least one course in the following seven categories: communication, math, American citizenship, behavioral/social science, literature/fine arts, science, and global civilization. If you have fulfilled at least five of these categories prior to coming to OC, you will be able to complete courses on campus to fulfill up to two deficient areas in the seven categories
5. You must complete a minimum of 30 semester hours in a major and a minimum of 18 hours in a minor. At least one-half, or 22 hours (whichever is smaller), of the work in the major or major/minor program must be completed at OC. In majors that contain a specialization, at least three-fourths of the work required for that specialization must be completed at OC
6. Only courses with a grade of "C" or better will transfer. You must have a total GPA on all courses of not less than 2.0 and the same overall average on all work done in the major field. Remedial and developmental courses will not transfer.
7. You must have 2 science courses (6 hours total) one of which must include a lab
8. Students transferring with an Associates degree will be required to complete 6-8 hours of Bible to include *BIBL-4523 – Capstone: Christ and His World*
9. Transfer students must take the following number of hours in Bible at OC:
Transfer hours Required OC Bible hours
 - 1 to 12 16*
 - 13 to 31 14*
 - 32 to 47 12*
 - 48 to 63 10*
 - 64 to 79 8*
 - 80 or more 6*
 - Or reach the total of 16 hours, including transfer hours.

*The number of Bible hours required for transfer students is determined at the time of your initial enrollment at OC. Subsequent transfer hours do not affect the number of hours required

10. Representatives from OC and OCCC will periodically update transfer and

admission policies, ensure that appropriate information is readily available to OCCC students, and work together to develop mutually beneficial arrangements between the two institutions.

11. This agreement articulates transfer of OCCC degree programs in Business.

Notice of Change or Cancellation

Either institution may change or cancel this agreement by notifying the other no less than one academic year before the intended date of change or cancellation.
