Proposed Amendment to:

CONSTITUTION

FACULTY ASSOCIATION OF OKLAHOMA CITY COMMUNITY COLLEGE

Purpose: The proposed Amendment is to define a procedure for collection of dues which will result in an increased level of accountability regarding the amount of money collected in dues and the individuals who are dues paying members of the Faculty Association.

Under

Article II

Membership

it is proposed that the following be added:

Section 3. Collection of Dues

- Each member of the Executive Committee shall be in possession of a receipt book.
- The primary point of contact for the collection of dues in a Division will be the Executive Committee representative from that Division.
- The member of the Executive Committee receiving a member's dues shall fill out a receipt acknowledging the receipt of the dues, giving a copy of the receipt to the member.

- After receipting the dues, the individual receiving the dues shall record the following on a record sheet:
- 1. The member's name
- 2. Amount received
- 3. Method of payment.
- At the next meeting of the Executive Committee, all dues and record sheets shall be delivered to the Faculty Association Treasurer for accounting.
- The Treasurer and one other member of the Executive Committee shall both tally the delivered record sheets to determine the amount of dues received.
- After tallying, two copies of the record sheets shall be maintained, one by the Treasurer for purposes of audits and the other by the Secretary for purposes of maintaining a list of members.

Minutes Faculty Association Meeting Tuesday, January 24, 2017

- 3. Treasurer's Report was presented and approved, as of January 24, 2017:

Ann Raia, librarian, updated the faculty on library use numbers and presented LibGuides. Please contact her or other librarians about creating LibGuides for your division or courses.

5. Chair Report:

<u>VPAA:</u> Search has been re-opened. There are three faculty members on the committee.

<u>Diversified Studies/Advising Committee:</u> OCCC has formed an ad hoc committee consisting of two faculty members and Mary Ann Bodine-Al-Sharif (Director of Recruitment and Admissions) to investigate the practice of assigning Diversified Studies degrees/majors. If students are not getting a program specific

degree, because they were advised their hours can be used for a diversified studies degree for transfer credit, the students may miss out on scholarship opportunities, professional organizations etc at the 4-year institution.

6. Old Business:

- a) Scholarship Committee: \$3,100 was given to students last fall for scholarships. Soup and Bake Sale will be held late February/beginning of March.
- b) Membership dues collection by-laws update: The proposed amendment to the faculty association constitution was presented and will be emailed to the faculty. Faculty is requested to read the amendment, suggest any changes to the amendment. The amendment will be voted on during the February faculty association meeting.
- c) Faculty/Regents Roundtable: Will take place Monday, February
 20. Six of the regents will attend. Sign-up sheet was circulated.

7. New Business:

- A. Academic Dishonesty and Copyright of Faculty Materials:
 Proprietary material of OCCC faculty has been sold online by a
 student. OCCC does not have a copyright policy. There were no
 repercussions for the student. President Steward has agreed to hire
 a copyright expert for a presentation to the faculty. The chair
 asked faculty to form a committee to develop a copyright policy.
