The members think it would be beneficial for the FA President to meet with the OCCC President once a month, similar to meeting with the VP's. The FA members

believed it would be important to strengthen our relationship with the OCCC President, as next year will be our first year with the new OCCC President.

It was requested that we review our accomplishments during the 2014-2015 year.
