Background and Summary

- The College's Access END, established by the OCCC Board of Regents, states: Our community has broad and equitable access to both highly valued certificate and degree programs and non-credit educational opportunities and events.
- There are three core indicators used to measure student access in the College's FY 2013 Annual Plan. Based on the latest available information, performance on these targets is:

During the last several years, the College has demonstrated strength in the following areas:

- Historically underserved racial and ethnic groups are represented in the student population in higher percentages than the overall population in the five-county area.
- Based on OCCC's affordability and the diversity of its student population, we believe the College is providing broad and equitable access to a college education.

Areas for improvement include the following:


- FTE market share has declined slightly.
- FTE enrollment has declined.

Market Share

Target: Total FTE market share will be at or above 47.1%.

Market share is a way to measure the relevance of course offerings, affordability, and the quality of student support. External factors such as demographics and the economy affect enrollment, but market share is a consistent way to measure progress in good and challenging times.



Local FTE Market Share

 OCCC's community college market is defined as the credit hours of Rose, OSU-OKC, and OCCC during an academic year. The College's FTE (FTE =30 credit hours) market share declined slightly from FY2012 to FY2013. OSU-OKC increased 0.3 percentage points and Rose gained 0.1 percentage points. However, the College's unduplicated headcount market share (see Appendix, page 10), which is another good measure of the College's access mission, remained essentially flat during the year at nearly half of the market. The principal difference was the higher average credit hour per student at OSU-OKC (27.5% of the credit hours with 25.8% of the students). This discrepancy might be accounted for by the fact that OSU-OKC has a different demographic profile than OCCC i.e. OSU-OKC has more full time students.


Target: FTE enrollment will increase over the target of 9,589 (prior three-year average).

• FTE enrollment was 8,924 in FY13 which was lower than the three year average of 9,589 therefore leading the College to not meet the FTE enrollment target. The College's Headcount also decreased. During the 10-year period unduplicated headcount grew 9.6% while credit hour enrollment 13.3%.

Student Characteristics – Race and Ethnicity

Target: OCCC's racial and ethnic composition of the student body will exceed the five-county area's composition of 34.7%.



 OCCC's student population has a greater ethnic and racial diversity than the five-county area from which we draw 93% of our students. 40.0% of the OCCC student population was racially and ethnically diverse compared to the five-county region of 34.7%. This has been a continued trend for a number of years.

Results from FY2013 Improvement Strategies

- The new Enrollment Management Committee will analyze groups and areas where the College has experienced attrition and recommend/implement an integrated set of interventions to increase enrollment. Particular areas of emphasis will include increasing OKC-Go enrollment, increasing the number of students from certain geographical areas (Northwest and North Oklahoma City especially) and finding ways to appeal to adult students. Below are initiatives enacted to aid in recruitment of populations identified as declining or flat in enrollment:
 - Hired a Coordinator of International Student Services and made adjustments to the International program to address customer service, efficiency of processes, policies, and laws.
 - Assigned an Admissions and Outreach Advisor to the NE and NW Oklahoma City Schools. We have increased school visits to these schools by 20.5% in FY14.
 - Revamped and reintroduced the OKC-Go program to the community with a specific emphasis placed on underrepresented groups.
 - Targeted new transfer summer enrollment by more heavily promoting to out of the metro institutions (OSU, SWOSU, NEOSU, etc.).
 - Promoting summer enrollment through the Concurrent Momentum program, encouraging students who will graduate in May and who are concurrently enrolled to keep the momentum and enroll for the summer.
 - Actively using targeted tuition waivers for adult students. These include the BADNAP Booster, Degree Completion, Career Development, Generation GO (new name for OGO Too).
- A task force of faculty has been commissioned to analyze and propose recommendations for increasing online enrollment in that increasingly competitive market. This analysis will investigate best practices in course design, course delivery and content promising formats such as hybrid courses.
 - Some projects addressing online improvements to be implemented this summer include: 1) reduced cost or free course required software for students, 2) developing a website to show students what they need to take an online course, 3) provide an online advising system which would include a call back process, and 4) reaching out to faculty and staff to let students know that tutors are available online.
 - Future projects include mandating that all faculty who teach online be trained, identify a 3rd party vendor for Internet and computer sales, develop a plan to review all online courses every three years, and expand online degree programs.
- Academic Affairs will investigate and implement new degree programs and certificates for both the traditional classroom and online, and recommend new improvements designed to increase business enrollment.
 - The Science program was redesigned to offer multiple specifically identified programs to facilitate advising and ease the transfer process for students.
 - Little progress was made with the business enrollment. We will redouble our efforts this year.

Improvement Strategies for FY 2014

- As part of the Central Oklahoma Regional Educational network or CORE (A team of administrators, faculty and IR staff from OCCC, OKC Public Schools, and UCO) the College will work to remove barriers to student success, create new programs to respond to the needs of local employers and provide a venue for sharing best practices in teaching and learning.
- The new Business Division Dean will be tasked to provide the College with increased employer visibility and strengthen ties with area businesses.
- In conjunction with the OCCC Foundation the scholarship program will be evaluated to determine if it reflects the College's mission priorities and whether the program competes favorable with other community colleges.
- Academic Affairs and Enrollment & Student Services will explore the possibility of offering a form of the Success in College and Life course for pre OKC-Go students in the Spring and Summer as a concurrent course for seniors in the Oklahoma City School District and Western Heights.
- The College will begin the implementation of the Enrollment Management Plan which is anticipated to be completed in June of 2014.

Longer Term Improvement Strategies


- The OCCC Capitol Hill Center will provide credit instruction which will serve as the entry point for community college students, many of whom are from Oklahoma City's fastest growing demographic group, the Latino community.
- Increase concurrent enrollment within the Oklahoma City Public School system.
- The College will monitor the impact of the changes the Higher Learning Commission will require of our relationship with Technical Centers. These changes will take effect in FY2016.


Market Share

■OCCC ■Rose ■OSU-OKC


Comment: While the FTE OCCC market share declined, the unduplicated headcount market share increased slightly.

Comment: This is the third year in a row that the College's share of Oklahoma City Public School graduates attending OCCC in the subsequent semester increased.


Part/Full-Time Students & New/Returning Students



Part-Time/Full-Time Students




Comment: The percentage of part-time students (those who take less than 12 hours in a semester) decreased slightly from Fall 2012 to Fall 2013.




New and Returning to OCCC

Online Enrollment




Comment: For the fourth consecutive year the online course credit hours as a percent of the total number of credit hours increased.

Comment: One-in-seven students took courses exclusively online as a percent of the total unduplicated headcount. For the first time in the last seven years the number of students who took at least one online course at the College declined between 2012 and 2013. The market for online students has become very competitive.

Comment: OCCC partners with area Technology Centers to provide technical training to area residents. There was a slight decline in the number of FTEs.



 The Higher Learning Commission has recently determined that we can no longer call our relationship with the technology centers "other locations." Instead, they have determined that if we continue to partner with them for college credit, we need to establish a contract with them. In addition, in FY2016, we will no longer be able to count enrollment or graduates from the technology centers unless we have a contract. Our OCCC Director of Cooperative Alliances, Director of Curriculum and Assessment, and the Associate Vice President for Academic Affairs have been working with other community colleges and the OSRHE to develop a plan to address these issues. The new plan will go into effect during FY 2016 so it is unknown what the total impact will be on the College's enrollment or number of graduates.

International Students



Comment: The number of International students continues to decline. The number of Chinese students accounts for the largest number of the College's international student population with 97 which is a significant increase from the 2009 population of 18. Nepal students declined markedly from a high of 145 in 2009 to a low of 26 this year. South Korea also declined from 53 to 32, Kenya 30 students to 21 students and India 21 students to 9 students.



High School of Origin




Comment: The total amount of financial aid and the number of students receiving financial aid declined year-over-year in 2013 – the first time in five years. Some of this decline was due to the decline in enrollment while some of it was undoubtedly due to more federal financial aid regulations.

Comments: The number of students receiving free or reduced tuition through OCCC's OKC-Go increased slightly due to returning students. The Oklahoma Promise students declined from 893 in Fall 2009 to 838 in Fall 2013. In the years ahead, there could be pressure on the number of students that take advantage of Oklahoma Promise scholarships because of recent legislation mandating 30 hours a year full-time status. The vast majority of the Oklahoma Promise students at OCCC take less than 30 hours a year.
