## Background

The College's Community Development END states: **Our community's quality of life is enriched through our educational, artistic, recreational programs, and events.** 

Note: The financial information used in this report includes only direct program revenues and expenses. Other costs and revenues were excluded. In addition, as we review the public cost and public benefit of the programs in community development, it may be of value to note that most colleges view the community service function, programs, and costs as a mission-related and effective way to build goodwill in the community. The goodwill generated assists in no small measure in the marketing of the college, recruitment, fundraising, and general support from members and organizations in the community, including our elected officials at both the state and local levels.

There are 5 core indicators used to measure Community Development in OCCC's FY 2017 Annual Plan. Based on the latest available information, performance on the targets is as follows:

Target	Performance <sup>1</sup>
Improve aggregate margin for selected Community Development functions —	
including a breakeven financial position for PDI on direct cost basis.	
ABE/HSE/ESL will achieve at least 5 national benchmark levels assessed which is what it achieved in FY2016.	
Enrollments at OCCC Capitol Hill Center will be higher than the prior year which was 1,589 in FY2016 and 974 in FY2015.	
Performing Arts Series tickets sold will be at or above the prior three-year average of 3,713. FY2016 was 6,088.	
Visual Performing Arts Center Theater will have at least 290 event days (includes VPAC theater, art gallery, and lobby events). There were 435 event days in FY2016.

## Summary

- During the most recent year, OCCC has experienced progress in the following:
  - The Visual Performing Arts Center Theater increased the number of events held by 29.7% from the prior year.
  - PDI has shown a margin loss for FY2016 that is lower than the loss in the previous fiscal year.
- Opportunities for improvement:
  - ABE/HSE/ESL measures were below the previous year.
  - The Performing Arts Series tickets sold were slightly lower in FY2016 than in FY2015.

## **Revenues, Expenditures, and Margins**

**Targets:** Community Development financial performance will improve aggregate margin for selected community development functions. PDI will be breakeven on a direct cost basis.



Targets: ABE/HSE/ESL outcomes will be at or above half (5) of the national benchmark standards.




## ABE/HSE/ESL Number of National Benchmarks Measures Met (10 Measures)

Target: Enrollments will increase over the prior year at the OCCC Capitol Hill Center.




### **OCCC Capitol Hill Center Enrollments**


## **Performing Arts Program Activities**

**Target:** Performing Arts Series tickets sold will be at or above prior three-year average of 3,713. The number of event days attributed to the Visual Performing Arts Center Theater, Inasmuch Foundation Gallery, and Atrium will be at least 290 event days.



#### Performing Arts Series Tickets Sold

The number of Performing Arts Series tickets sold declined from the previous year by 573 tickets or 8.6%. However, it is important to note that an additional 2,666 tickets were sold for add-on events.

  - Increase facility rentals.
    - ✓ Executed facility rental and usage contracts with new clients: OKCPS, Goodwill Industries, LP Gas Commission.
- Increase the usage of the Visual and Performing Arts Center and the Bruce Owen Theater.
  - Continue to increase the number of events.
    - ✓ The number of events at the VPAC theater, atrium, Art Gallery and Bruce Owen Theater were 288 in FY2015 and 356 in FY2016.
  - o Continue to promote the VPAC and the Bruce Owen Theater as rental facilities.
    - ✓ The Director of Cultural Programs has attended numerous formal functions, i.e., Oklahoma South Camber, Rotary, and other leadership events to share information on the VPAC facilities including the theater. Casual settings also provide an opportunity to promote the special features of the facilities. Contacts have also been made with agents and promoters to provide them with information and share with them the options for using the facilities. The Theater is now listed in the Pollstar's Directory of Venues.

### **Opportunities for Improvement**

- Work to integrate Adult Basic Education/General Education Degree to increase benchmarks
- Continue to improve the profitability and competiveness of the Professional Development Institute






The program has served nearly 25,000 students since 2008. At the end of December 2016 we had already served 3,289 this fiscal year which started in July of 2016.



Some of the courses taught were alternative fuels, pharmacy technician, industrial maintenance technician, Commercial Food Equipment Services Technician (CFEST), comparative religions, and Accounting I. Online programs offered including short term, long term and career step programs in areas such as computer software, pharmacy, and medical coding.
