Background and Summary

- The College's Access END, established by the OCCC Board of Regents, states:
 Our community has broad and equitable access to both highly valued certificate and degree programs and non-credit educational opportunities and events.
- There are five core indicators used to measure student access in the College's FY 2017
 Annual Plan. Based on the latest available information, performance on these targets is:

Target	Performance ¹
Headcount market share will be above 51.1%. The most recent market share rate was 49.6%.	
FTE credit hour enrollment will be above the prior three-year average of 8,491. FY17 was 8,035.	
The number of students graduating from Oklahoma City Public Schools and Western Heights Public Schools attending OCCC in the Fall 2017 will be above the prior three-year average of 440. The Fall 2017 headcount was 527 students.	
The number of students completing FAFSA will be above the prior three- year average of 10,422. For FY17, 9,085 students completed FAFSA forms.	
The college exceeded the 2 new programs/options and/or articulation agreements by adding 2 new academic programs, 4 certificates and signed 14 articulation agreements with other universities.	

During the last several years, the College has demonstrated strength in the following areas:

- The Oklahoma City Public Schools and Western Heights Public Schools graduates attending OCCC has increased.
- Seven of the 15 fastest growing jobs are included in programs offered at OCCC.

Areas for improvement include the following:

- The number of credit hour enrollments were below the last two years.
- The headcount market share was flat for two years and then declined



Market Share

Target: Total headcount market share will be above 51.1%.

Market share is a way to measure the relevance of course offerings, affordability, and the quality of student support. External factors such as demographics and the economy affect enrollment, but market share is a consistent way to measure progress in good and challenging times.

Local Market Share of Annual Unduplicated Headcount





 The OCCC unduplicated headcount market share is determined by adding the unduplicated headcount of Rose, OSU-OKC and OCCC and dividing each one by the total. The College's market share decreased. OSU-OKC increased 0.8 percentage points and Rose increased by 0.7 percentage points.

Enrollment

Target: FTE enrollment will increase over the target of 8,491 (prior three-year average).






FTE enrollment was 8,035 in FY17, which was lower than the three-year average of 8,491. The
College's headcount also decreased. The 3-year average is used to smooth out the volatility in this
measurement to better spot long-term trends.

Number of Students from Oklahoma City Public Schools and Western Heights

Target: The number of new OCCC students graduating from OKCPS and Western Heights will be above the average of the prior three years of 440.



The current information is based on the number of new incoming students who graduated from one of the designated Oklahoma City Public Schools or Western Heights Public Schools in the previous year. The number is above the three-year average. The number of students increased 125 students or 31.1% since last year.

Students Completing Free Application for Federal Student Aid

Target: The number of students completing the Free Application for Federal Student Aid (FAFSA) will be above the average of the prior three years of 10,422.



The number of applicants in FY2017 was less than the target of the three-year average and was related to the overall decrease in enrollment.

Academic Programs and Articulation Agreements

Target: Two new academic programs/options and/or articulation agreements developed, approved, and implemented by the end of FY2017.


Future Issues

Credit Student Headcount by Semester


Student Headcount by Semester*


Comment: Each of the semesters declined over the past five years.

Comment: Returning students as a percentage of the student body held steady compared to Fall 2016.


Online Enrollment

Comment: Online course credit hours as a percent of the total continues to increase.


Students Who Took at Least One Online Course

International Students






Comment: The number of International students declined from the previous fall. Students from Nepal account for the largest number of the College's international student population.
