# **AOAC Meeting Minutes**

October 25, 2018

#### I. Call to order

### III. Approval of minutes from last meeting

- a) Dr. Green thanked all attendees for providing feedback on Section III of the program reviews.
- b) In regards to reviewing Section III in the future, Chris Oehrlein suggested that it would be beneficial to have programs also have summary of five years of assessment completed to assist with giving feedback on Section III.

### V. New business

- a) Committee discussed how Gen. Ed. Outcomes and expectations are handled, particularly about artifacts. Some questions of discussion included whether or not all programs have to contribute to all Gen. Ed. Outcomes, how many artifacts are collected on average, and what kinds of artifacts are collected for the various programs.
- b) Dr. Perry discussed the significance of program reviews reflecting what OCCC is doing based on assessment results. Program reviews should reflect what changes

the institution is implementing based on artifact assessments. Noted initiatives includes curricular refinement and 2x2 development.

- c) Faculty are still working on program reviews. The next part to be submitted is Section IV of the form; it is due Nov 19. AOAC members will review and provide feedback on Part III in the next meeting on November 29, 2018. Provide feedback in the "Documents for Committee Review" section on the Blackboard Open course. - d) Dr. Green provided an overview of Section IV of the program review form.
- e) Committee discussed the impending math pathways and the need to talk to all divisions about the forthcoming changes. The math pathways will impact evaluation and Gen. Ed.
