Curriculum Proposals:

1. Associate in Art in History-Course Deletion

To more suitably meet the needs of History majors, the history faculty propose to delete HIST 2153 Survey of American Families and Communities and HIST 2213 Great American Biographies. The Course Equivalency Project (CEP) stipulates that just one course be entered in any given section. Both of these courses, in addition to one other, were entered as United States Cultural history which violated OSRHE policy. To be in compliance with OSRHE policy, and to facilitate student transfer and graduation, the History faculty recommend the deletion of HIST 2213 Survey of American Families and Communities and HIST 2213 Great American Biographies.

Motion to approve the deletion of HIST 2153 Survey of American Families and Communities and HIST 2213 Great American Biographies was made by Dr. Jennifer Allen and seconded by Mr. Ron Feller.

2. Associate in Arts in Political Science/Pre-Law-Course Deletion and Curriculum Pattern Modification

To more suitably meet the needs of Political Science majors, the Political Science faculty proposes deleting POLSC 2613 Scope and Methods of Political Science and POLSC 2543 Religion and Politics. POLSC 2613 was originally created to help ensure students were being assessed adequately before graduation. The program no longer is assessing students via this strategy, therefore the course is no longer

necessary. In addition, the deletion of POLSC 2543 is requested as the course does not appear on the CEP matrix

Motion to approve the deletion of POLSC 2613 Scope and Methods of Political Science and POLSC 2543 Religion and Politics was made by Ms. Jill Hibblen and seconded by Dr. Steven Shore.

With the deletion of POLSC 2613, program majors will be able to complete twelve credit hours of Political Science electives. This opportunity should simplify student transfer into the various OU or UCO Political Science degree options, including Public Administration.
