Curriculum Proposal-Physical Therapy Assistant

Ms. Jennifer Ball proposed to add two one credit hour courses, Clinical Prep I and Clinical Prep II to be completed in the semester prior to PTA 1312 Initial Practicum (spring of the first year in the program) and prior to PTA 2034 Practicum I (fall of the second year in the program) respectively. The accredited PTA program requires clinical education to allow the students to apply the knowledge they have learned from the didactic courses with actual patient care. Prior to the clinical education coursework, the students are required to demonstrate competency. The Clinical Prep courses will allow that specific assessment to be part of the course requirements. In addition, the clinical settings are very complex and specific to the settings/patients that they serve, amounts of required PT/PTA supervision, documentation requirements, and reimbursement issues. The Clinical Prep courses will allow that specific information to be conveyed to the students and incorporate guest presenters to discuss the ongoing health care changes. Additional approval is required from OSRHE.
