Agenda Item 1: Dr. Schwark presented the assessment process in the Business area.

- Most of the programs/options fall under the regulations required by the accreditation of The Association of Collegiate Business Schools and Programs (ACBSP).
 - This accreditation membership sets standards to ensure quality regardless of program and aid in the transfer process. All but three colleges in Oklahoma have this national accreditation.
 - All core courses are reviewed fall and spring. Data is to be reviewed and any weakness addressed. The assessment team is made from faculty from various options. Program faculty determine and embed assessments within core coursework. Part of maintaining accreditation with ACBSP is demonstrating the collection of data, scrutiny of that data, and making appropriate changes where needed based on this data and analysis.

Agenda Item 2: Mr. Tom Ashby presented the assessment process in the Information Technology area.

• The IT area has three programs—one AS and two AAS. Much of IT's assessment process is based on clear outcomes for assessment. There are many options under each program. One AAS has outside accreditation through the Accreditation Board for Engineering and Technology (ABET). This program also assesses it program through a portfolio.
