Curriculum Proposals

1. Business-Presenter Dr. Germain Pichop

Dr. Pichop proposed to suspend the Business Management and Business Aviation Management options from the Associate in Science in Business Program.

Dr. Pichop proposed the course name ECON 1013 Consumer Economics should be changed to ECON 1013 Introduction to Economics, and the course description updated to meet current content needs.
